Applications are invited from Indian Citizens (Male & Female) for appointment to **Group** 'A' post of Super Specialist Medical Officers (Second-in-Command), Specialist Medical Officers (Deputy Commandant) and Medical Officers (Assistant Commandant) in Central Armed Police Forces (BSF, CRPF, ITBP, SSB) & Assam Rifles, Ministry of Home Affairs, Government of India. On joining, a candidate shall be governed by the Act and Rules, as amended from time to time, applicable to the organization to which he is allotted after selection. Selected candidates will be liable to serve anywhere in India or abroad as per requirements of service. On appointment, the candidates shall be entitled for the pension benefits as per the 'New Restructured Defined Contributory Pension Scheme' applicable for the new entrants to the Central Government Services w.e.f. 01.01.2004.

Applications from candidates will be accepted through 'ON-LINE MODE' only. No other mode for submission of application is allowed. Candidature of candidates who submit offline application will be summarily rejected. 3. **Qualification**:-

(A) For Super Specialist Medical Officers (Second-in-Command)

- (i) A graduate degree in Medicine (M.B.B.S.) or equivalent from a recognized university/Institution included in the first schedule to the Indian Medical Council Act, 1956, and
- (ii) Should be enrolled in any State Medical Register maintained under the Act, and
- (iii) Should have completed compulsory rotating internship, and
- (iv) Should also posses Post Graduate Degree or Diploma in the related Specialty mentioned in Section 'A' or Section 'B' in Schedule I to the Indian Medical Council Act,1956 (102 of 1956) or equivalent, and

- (v) Should posses Doctorate of Medicine (DM) or Magister Chirurguie (M.Ch.) or equivalent with three years experience in the concerned Super-Specialty after obtaining the first post-graduate degree. Senior Residency period will also be counted towards experience, physical and medical standard, and
- (vi) The applicant must have permanent registration from MCI/NMC/State Medical Council before appointment.

(B) For Specialist Medical Officers (Deputy Commandant)

- (i) A recognized medical qualification of allopathic system of medicines included in the first or second schedule or part–II of the third schedule (other than licentiate qualification) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part–II of the third schedule should also fulfill the conditions stipulated in Sub Section (3) of Section (13) of the Indian Medical Council Act, 1956. The applicant must have permanent registration from MCI/NMC/State Medical Council before appointment in any of the CAPFs & AR, and
- (ii) Completion of compulsory rotating internship, and
- iii) Should also possess Post Graduate (PG) Degree/Diploma in the concerned specialty mentioned in Section 'A' or in Section 'B' in Schedule-I or Equivalent and one and half years experience in the concerned speciality after obtaining PG Degree or two and half years experience after obtaining PG Diploma.

(C) For Medical Officers (Assistant Commandant)

- (i) A recognized medical qualification of allopathic system of medicines included in the first or second schedule or Part–II of third schedule (other than licentiate qualification) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part–II of the third schedule should also fulfill the conditions stipulated in Sub Section (3) of Section (13) of the Indian Medical Council Act, 1956.
- (ii) The applicant must have permanent registration from any MCI/NMC/State Medical Council before appointment in any of the CAPFs & AR, and
- (iii) Completion of compulsory rotating internship. Candidates who may be undergoing the rotating internship shall be eligible to apply and appear for the interview provided that if selected, they shall have satisfactorily completed the compulsory internship before appointment.

4. <u>AGE LIMIT</u>

- (i) The age limit for recruitment of **Super Specialist Medical Officers (Second-inCommand)** should not be exceeding 50 years as on the closing date of receipt of application.
- (ii) The age limit for recruitment of **Specialist Medical Officers (Deputy Commandant)** should not be exceeding 40 years as on the closing date of receipt of application.
- (iii) The age limit for recruitment of **Medical Officers** (Assistant Commandant) should not be exceeding 30 years as on the closing date of receipt of application.

- (iv) Relaxation in age limit for recruitment of Super Specialist Medical Officers (Second-in-Command), Specialist Medical Officers (Deputy Commandant) and Medical Officers (Assistant Commandant) shall be as under:-
 - (a) Upto a maximum of five years for Scheduled Caste (SC) or Scheduled Tribe (ST) candidates.
 - (b) Upto a maximum of three years for Other Backward Class (OBC) candidates.
 - (c) Upto a maximum of five years in the case of Government servants (Civilian central Government servants). The term "Civilian Central Government Servant" will apply to persons who are defined as "Government Servants" in the Central Civil Services (Classification Control and Appeal) Rules, 1965 as amended from time to time.
 - (d) Upto a maximum of five years in the case of Medical Graduates who joined Army Medical Corps as Short Service Regular Commissioned Officers and are released after completing the initial period of assignment of five years. The relaxation upto five years shall also be admissible to the SSCOs whose assignment has been extended beyond five years and in whose case the Ministry of Defence issues a certificate that they will be released on three months notice on selection from the date of receipt of offer of appointment.
 - (e) The relaxation in age limit shall be admissible upto a maximum of ten years if such Govt. Servants and SSCOs belong to the Scheduled Caste or the Scheduled Tribe and upto a maximum of eight years if such Officers belong to the Other Backward Classes (OBCs).
 - (f) There will be relaxation in age for other categories of persons in accordance with the Government orders on the subject.

5. METHOD OF SELECTION

Candidates, whose online applications are found in order, will be issued e-admit card mentioning date, time and venue for 'Documentation & Interview' by a designated Board of Officers at the designated centers followed by Physical Standard Tests (PST) and Medical Examination Tests (MET), to assess their suitability for appointment in CAPFs & AR. Selection process will be conducted as per the following sequence:-

(A) Documentation

All candidates, who have been issued online admit cards and called for Interview will bring a clear and legible print out of the admit card and **following original testimonials along with one set of self attested copies of the same**, else they may not be permitted to enter the venue:-

- i) Matriculation/School Leaving Certificate in support of Age/Date of Birth.
- ii) Certificate in support of qualification as mentioned at Para-3 of this advertisement notice.
- iii) Certificate in support of completion/undergoing internship. iv) Registration certificate from MCI/NMC/State Medical Council.
- v) Scheduled Caste and Scheduled Tribe Certificate as per **Annexure-'V'**, OBC Certificate as per **Annexure-'VI'** and EWS Certificate as per

- **Annexure-'VII',** if belonging to these category, issued by an authority not lower than Tehsildar, SDO or any equivalent officer.
- vi) Candidates seeking reservation as OBC (NCL) shall submit a declaration as **Annexure-'VI-A'**.
- vii) Candidates claiming OBC (NCL) status may note that certificate on creamy layer status as per **Annexure-VI** should have been obtained within three years before the closing date of online application i.e. 16.03.2023 and must ensure that he possesses the caste/community certificate and does not fall in creamy layer on the crucial date i.e. on 16.03.2023
- viii) Candidates claiming EWS status must have 'Income & Asset Certificate (I & AC)' as per the assessment of the Income & Assets for the 'Financial year 2021-2022 valid for the year 2022-23', issued before the last date of receipt of online application i.e. 16.03.2023 as per Annexure-VII.
- ix) NOC in the case of Government Servant (Civilian Central Government Servants) candidate, as per **Annexure-III**.
- x) Discharge certificate in case of Ex-Servicemen
- xi) Domicile Certificate issued by local revenue authorities or PAN Card or Aadhar Card or Driving License or Voter ID Card or Passport for verification of citizenship.
- xii) In case of West Pakistani Refugees settled in J&K, certificate in the format attached as **Annexure-VIII**' issued by the Sarpanch/Numberdar/ Naib Tehsildar of a candidate's village to the effect that the person belonged to the West Pakistani Refugees Category, along with a copy of Electoral Roll showing the name of the candidate in the voter list for elections to the Parliamentary Constituency.
- xiii) Candidate intends to avail relaxation in height measurement shall have to submit certificate as per **Annexure-IV**, whenever sought by the Recruitment Board.
- xiv) NCC Grade Certificates, where available.

(B) <u>INTERVIEW:</u>

The designated board will conduct interview of the candidates found eligible after documentation. The interview will carry 200 marks and shall be conducted to test the General knowledge and ability of the candidates in the field of their academic study and also to assess the nature of personality, intellectual curiosity, and balance of judgment and alertness of mind, ability for social cohesion, integrity of character, initiative and capability for leadership of the candidates. Minimum Standard for the purpose of selection at the level of Interview shall be 40% of the total marks prescribed for interview (i.e. 40% of 200 = 80). The minimum qualifying marks are same for all categories of candidates. Candidates not qualified at the level of interview shall be eliminated from the selection process.

(C) PHYSICAL STANDARD TEST (PST):

- (1) All the candidates, who qualify the Interview, shall be checked for the Physical Standards by a designated Board of Officers on the same day or on the next day following the date of interview.
- (2) Those who do not meet the minimum required physical standards as under will be eliminated at this stage.

- (3) The candidates, who are declared not qualified in physical standards i.e. height and chest (as applicable), may prefer an appeal on the same day, if they so desire, to the appellate authority nominated for the centre, through the Presiding Officer PST Board. The decision of the appellate authority will be final and no further appeal or representation in this regard will be entertained thereafter.
- (4) The candidates should conform to the following physical standards:-

(D) <u>MEDICAL EXAMINATION TEST (MET):</u>

Board.

- (1) Candidates qualified in Physical Standards Test (PST) will be required to undergo Medical Examination Test (MET) by a duly constituted Board of Medical Officers of CAPFs & AR on same day or the following day of PST.
- (2) Selection to the post is subject to candidate being found medically fit by a Board of Medical Officers as per the medical guidelines issued by Ministry of Home Affairs (Government of India), for direct recruitment in CAPFs & AR vide MHA UO No. A.VI-1/2014-Rectt (SSB) dated 20/05/2015 and amendments issued from time to time.
- (3) Candidate will either be declared "FIT" or "UNFIT" in Medical Examination Tests.
- (4) Those who will be declared Unfit during Medical Examination Tests (MET) will be allowed to undergo "Review Medical Examination (RME)" provided they give their written consent by appending their signature on the

- intimation indicating the reasons for being unfit, as per Annexure-'IX' given by the Presiding Officer of the recruitment centre.
- (5) The consent for RME as per Annexure-'IX' duly signed by the candidate shall have to be submitted by the candidate within 24 hours after he/she is informed for his/her unfitness in Medical Examination Test.
- (6) Review Medical Examination (RME) will be conducted in continuation of Medical Examination Test (MET) preferably on the next day

However, no Radial Keratotomy (RK) or another refraction surgery is permitted.

(ii) **Lasik Surgery correction is permitted subject to prescribed criteria as under:

(a) Interval - 6 months(b) Age - 20-35 Years

(c) Axial length - Less than 26 mm and more than 21 mm

(d) Corneal thickness - 425 micron

(e) Pre Lasik error - 6 D

(f) Vision - As per medical guidelines

(g) Retinal status - Normal

- (iii) Candidate must not have knock-knees, flat foot or squint in eyes and they should possess high colour vision. The candidates will be tested for colour vision as per medical guidelines in vogue. A candidate having colour perception below CP-III will not be eligible for appointment.
- (iv) Every candidate will give an undertaking at the time of joining that at any stages of service career, if found not meeting the required colour perception

- standard as per his/her post, he/she will be boarded out as per SHAPE policy, in vogue.
- (v) Candidate must be in good mental and bodily health and free from any medical condition or physical defects likely to interfere with the efficient performance of the duties or is a cause of rejection as per the medical guidelines issued by Ministry of Home Affairs (Government of India), for direct recruitment in CAPFs & AR.

(vi) Tattoo clause:-

- (a) <u>Content</u>: Being a secular country, the religious sentiments of our countrymen are to be respected and thus, tattoo depicting religious symbol or figures and the name, as followed in Indian Army are to be permitted.
- (b) <u>Location</u>: Tattoos marked on traditional sites of the body like inner aspect of forearm but only left forearm, being non saluting limb or dorsum of the hands are to be allowed.
- (c) <u>Size:</u> Size must be less than ¼ of the particular part (Elbow or Hand) of the body.
- (vii) Every candidate on his/her having been selected will be examined by a duly constituted Medical Examination Board for his/her Medical Fitness. The Government of India reserve right to reject or accept any candidate after considering report of the Medical Examination Board.

Note: The above are the guidelines. The Medical Examination will be conducted as per the revised Medical Guidelines issued by MHA UO No. A.VI-1/2014-Rectt(SSB) dated 20/05/2015 and amendments issued from time to time.

6. **CAREER AND AVENUES:**

(A) EMOLUMENTS.

(i) For Super Specialist Medical Officers (Second-in-Command)

Super Specialist Medical Officers appointed in Grade-II will be granted the rank of Second-in-Command in the revised pay structure of the first cell in the Level12 of Pay Matrix or minimum pay in the first cell of Pay Matrix as specified in Part-A of the schedule of CCS (Revised Pay) Rules, 2016 pay scale Rs. 78,8002,09,200 per month plus other benefits like Non-Practicing Allowances, Dearness allowances, Transport Allowance, House Rent Allowance and any other allowances as admissible under Rules would be admissible as per the Central Government orders/provisions in existence and as amended from time to time. No Post Graduate allowance will be admissible as the basic essential qualification for the post is Post Graduate degree/diploma in a particular field of specialization.

(ii) For Specialist Medical Officers (Deputy Commandant)

Specialist Medical Officers appointed in Grade-II (Jr Scale) will be granted the rank of Deputy Commandant in the revised pay structure of the first cell in the Level-11 of Pay Matrix or minimum pay in the first cell of Pay Matrix as specified in Part-A of the schedule of CCS(Revised Pay) Rules, 2016, pay scale Rs. 67,700-2,08,700 per month plus other benefits like Non-Practicing Allowances, Dearness allowances, Transport Allowance, House Rent Allowance and any other allowances as admissible under Rules would be admissible as per the Central

Government orders/provisions in existence and as amended from time to time. No Post Graduate allowance will be admissible as the basic essential qualification for the post is Post Graduate degree/diploma in a particular field of specialization.

(iii) For Medical Officers (Assistant Commandant)

Medical

Officers appointed in any of the CAPFs will be granted the rank of Assistant Commandant in the revised pay structure of the first cell in the Level10 of Pay Matrix or minimum pay in the first cell of Pay Matrix as specified in Part-A of the schedule of CCS(Revised Pay) Rules, 2016, pay scale Rs. 56,1001,77,500 per month plus other benefits like Non-Practicing Allowances, Dearness allowances, Transport Allowance, House Rent Allowance and any other allowances as admissible under Rules would be admissible as per the Central Government orders/provisions in existence and as amended from time to time. No Post Graduate allowance will be admissible as the basic essential qualification for the post is Graduate degree/diploma in a particular field of specialization.

(B) **PROMOTIONAL AVENUES**

Note:- Promotion from the rank of Commandant to the rank of DIG (Medical) and IG (Medical) for Medical Officers and Specialist Medical Officers is by selection against sanctioned vacancy through a combined seniority list.

(C) PROVISION FOR PG COURSE

An officer can apply for PG entrance examination on completion of 5 years of regular service as per the instructions issued in this regard.

7. **OPTION FROM CANDIDATES**

- (a) For the posts of Specialist Medical Officers (Deputy Commandant) and Medical Officer (Assistant Commandant), candidates have to indicate their choice of preference in CAPFs, (BSF, CRPF, ITBP, SSB) & Assam Rifles. Candidates are required to indicate the choice of preference for all the CAPFs & AR in the order of preference. While making appointment, due consideration will be given to the preferences exercised by the candidates and having regard to their rank in the order of merit.
- (b) The post of Super Specialist Medical Officers (Second-in-Command) is available in ITBP only.
- (c) The choice of preference of CAPFs & AR once submitted by the candidate for the posts will be final and no request for changes of the choice of preference will be entertained.

8. MERIT LIST

Medical Officers Selection Board will prepare a merit list on the basis of aggregate marks awarded to each candidate during the interview. The Board will also compile merit list separately for SC/ST, OBC and EWS candidates.

9. **CONDITION OF SERVICE**

- (a) Posts of Super Specialist Medical Officer, Specialist Medical Officer and Medical Officer are combatised in CAPFs & AR and are governed by the Act and Rules of the respective organizations as amended from time to time.
- (b) Being a Super Specialist Medical Officer, Specialist Medical Officer and Medical Officer in CAPFs & AR, the candidate on appointment is liable to serve any part of the country or aboard as per service requirements. They may have to work independently in the units where they are posted.
- (c) Candidates shall be required to serve the Force for a minimum period of 10 years. If any officer after joining the service wants to resign from the service before the expiry of 10 years, he/she is required to refund a sum equal to three months pay

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for doing so, exempt any person from the operation of the rules for the recruitment of the post.
