The Institute follows reservation policy as per Government of India norms. Upper Age limit, qualification and experience for each post will be considered as on last date of closing the online application interface. Relaxation in age would be admissible as per the Government of India rules. For employees of IIT Patna and employees of other CFTIs (Centrally Funded Technical Institutions), the upper age limit will be 57 years and 50 years respectively, across all the posts.

The appointments will be made as per the Recruitment Rules and Promotion Policy of IIT Patna. 25% of vacancies for Group A and B posts shall be filled by internal existing employees of IIT Patna at lower levels, subject to availability of eligible candidates and their qualifying in recruitment procedure. In absence of internal eligible candidates, the posts may be filled through open recruitment.
